# INTRODUCTION



An estimated **60,000 children** live in construction site camps with slum-like conditions in Thailand. These children and their parents face critical challenges accessing essential services such as education, healthcare, and child protection. To address this often invisible issue, Baan Dek Foundation (BDF) aims to improve the fundamental well-being of vulnerable children and their families living in these communities by **supporting** their immediate needs, **empowering** their community leaders, and creating **systemic change** in the Thai construction sector.

# **OUR WORK**

BDF has a unique, sustainable programmatic approach structured across three interconnected programmatic pillars detailed below.

# SUPPORT Pillar 1: Support immediate child protection and child development needs



Through its child protection and child development programs, BDF provides temporary social and economic support to children and families to address critical, immediate needs. Addressing these needs is an essential step in generating long-term change and ending cycles of poverty for children and their families.



## **NPOWER**

Pillar 2: Empower communities

Through its community empowerment program, BDF provides specialized training to community members, adults, and youth to become agents of change who support children and families in their own communities in preventing child abuse, accessing public services, and improving their living environment.



CHANGE **Pillar 3: Change practices of** companies in the construction sector



To reach a change of practices at scale in the construction sector, BDF adopts a solution-oriented and positive approach based on partnerships with property developers and construction companies. Through the Building Social Impact Initiative, BDF offers a Framework for Action, practical tools, and company training sessions to improve the well-being of construction workers and their children.

# MEASURES OF SUCCESS

BDF monitors its impact on short and long-term intervals against specific indicators to maintain consistent, standardized improvements, identify new issues to address, and highlight meaningful success. BDF utilizes professional software for dynamic data management and data analysis.

All figures presented in this report represent cumulative achievements from January 2022 to October 2023, measuring BDF's progress towards its 2022-2025 targets.

At the center of BDF's work lies its Child Protection Program, which provides tailored case management, including direct and immediate protection, to children and families identified as at-risk. Meanwhile, the Child Development team ensures that every vulnerable child and youth is equipped with essential life skills and non-formal education to meet their developmental milestones and realize their full potential.

## **Child Protection Program**

Prior to BDF's support, our family was in a difficult situation. My husband did not have a permanent job and drank almost every day, and I could not send my daughter to school because I could not afford money for her lunch. We had to borrow money from other people to cover our expenses. However, through BDF's support, my husband got admitted to a rehabilitation center and received help in finding a suitable job. My daughter also received school support from BDF and now goes to school every day.





## **EMPOWER** Pillar 2: Empower communities

Through its community empowerment program, BDF addresses issues commonly faced by migrants by empowering their communities. BDF provides communities with essential information related to their rights, life skills, and access to public services and supports individuals to act as leaders of their communities.

## **Community Empowerment Program**

Peer Educators, trained to support community access to services, collaborating with BDF to help understand changing needs in communities and distribute aid.

vulnerable women engaged in upskilling training, financial literacy training, and/or work readiness activities. A total of 536 hard and soft skill workshop sessions were provided through the Women's **Empowerment Project in Chiang Mai.** 

vulnerable women were accompanied in their empowerment journey to rebuild their confidence, improve their employability, and increase their income through the partnership between BDF and Dao Ethical Gifts, BDF's spin-off social enterprise.





Through the Women's Empowerment Project at Baan Dek, I was able to continue learning and receiving important information on various topics like saving money for the future. By participating in the sessions with other mothers, I also realized that I was not suffering alone and felt empowered when we shared our stories with each other.

Leveraging social expertise generated by fieldwork under BDF's first and second Programmatic Pillars, BDF's third Programmatic Pillar builds systemic impact within the Thai construction sector. Together with the sector, BDF developed a Framework for Action, practical tools, and training to support companies in adopting improved practices toward migrant workers and their children living in construction site camps.

## Four Steps towards Systemic Change



In February 2022, BDF partnered with UNICEF Thailand and pioneering companies to launch the Building Social Impact (BSI) Initiative and its platform to encourage the construction sector to provide better living conditions for construction workers and their children in camps. The Initiative has engaged with various stakeholders in the construction ecosystem, including regulators, the Stock Exchange of Thailand, government partners (Ministries), and others to advocate for and promote positive behavioral change in the sector. One year after the launch, 14 companies have already joined the BSI Initiative, with more to follow!
