

Both income and expenses continued to grow in 2020, which is largely attributable to the global COVID-19 pandemic and exceptional emergency support provided by certain partners. Expenses for 2020 were planned and executed in line with the resources secured. To face increasing needs in the field related to the ongoing pandemic, BDF consolidated funds that will be used during 2021 to address the worsening crisis.

Dao Ethical Gifts is the social enterprise model of BDF. The Dao team trains marginalized women in production skills and work readiness, which makes it possible for them to reintegrate into society. These women produce ethical, hand-crafted products that are offered as corporate gifts. Any profit generated benefits the work of BDF, which supports children and families in need in Thailand. Dao Ethical Gifts is entirely funded through a restricted grant offered by Work Together Foundation and the funds generated through donations provided for handicrafts.

In 2020, under the mentorship of Social Enterprise Thailand, and with the support of pro bono lawyers from MHL Bangkok and SNA Solutions, BDF supported the registration of Dao Ethical Gifts Co., Ltd. This was done to enable the social enterprise model to operate independently of BDF starting in January 2021. An MoU between BDF and Dao Ethical Gifts Co., Ltd. will be drafted in 2021 to define the relationship between BDF and the company.
